Non-Photo Instruction Permit

This job aid is designed to assist you in coaching your customers through the Non-Photo Instruction Permit (NPIP) transaction. Customers must complete the pre-apply process through License eXpress before applying for a Non-Photo Instruction Permit.

Getting Started

Customers must have a DTS Waiver on record and meet the minimum age requirement of 15 years.

After customers log into License eXpress they must do the following:

- 1 Click the **Get your instruction permit** hyperlink. The link displays once the DTS Waiver is on record.
- 2 Review the **What you'll need** section.
- 3 Click the **Next**

Other Information

- The Driver Training School (DTS) sends the waiver, and DRIVES updates the record in real time.
- Non-Photo Permits are valid for one year.
